

## **NOTICE TO BIDDERS**

Sealed bids will be received in the Office of the Ottawa County Clerk, Robyn Mitchell, at 102 East Central Avenue, Suite 103 in Miami, Oklahoma 74354 until 9:05 AM on December 15, 2025. Bids will then be opened and read aloud by the Ottawa County Board of Commissioners on the following:

### **DOUBLE-BEVEL CURVED GRADER BLADES** ***FOR THE PERIOD JANUARY 1, 2026 THROUGH JUNE 30, 2026***

All grader blades must meet or exceed the following specifications:

Standard Grader Blades shall be “through-hardened” to the following minimums:  
Rockwell hardness C-Scale: Minimum of 43 (Rc43)  
Brinell hardness: Minimum of 400 (BR 400)

Bolt holes shall be standard sizes and spacing of 0.63” or 0.75” for use in conjunction with No 3 head-cutting edge bolts and use standard “highway” punching with either 6” or 12” spacing

Holes shall be spaced very accurately on a straight line and be located within 1/16” of the dimensioned position using both end holes as datum points

Supplier shall warrant that if a blade breaks during operation, it will be replaced free of charge

Bids submitted must be clearly marked on the outside of a sealed envelope:

**and must be accompanied by a completed and notarized “Statement of Non-Collusion” as required by O.S. 74, Section 85.22.**

The Board of County Commissioners reserves the right to reject any or all bids and/or make an award to other than the low bidder if such an award is deemed to be in the best interest of the County.

This bid is submitted as legal offer and any bid, when accepted by the County, constitutes a firm contract.
