Sealed bids will be received in the Office of the Ottawa County Clerks at 102 East Central Avenue, Suite 103 in Miami, Oklahoma 74354 until 9:05 AM on June 15th, 2026. Bids will then be opened and read aloud by the Board of Ottawa County Commissioner on the following:

The Ottawa County Sheriff's Office is looking for a security company to provide armed security for the Ottawa County Courthouse and Ottawa County Annex Building.

This will require two-armed security officers that will be expected to work Monday-Fridays, 0900-1700 hours. All Ottawa County holidays will be off along with any time the courthouse is closed mainly due to any inclement weather.

Duties will include:

Entrance Control: Enforce the courthouse entry by operating security screening equipment to detect weapons, contraband, and prohibited items. Checking items such as handbags, briefcases, computers, packages, baby carriages, wheelchairs, etc.

Roving patrol: Exterior: Foot patrol exterior of courthouse and parking lot including around the annex building that is to the north and detached from the courthouse.

Interior: Walk hallways of courthouse monitoring courtrooms and offices within the courthouse.

Stationary post: Main post is at entryway of courthouse, while at this post monitoring of closed-circuit security system and alarm systems will be expected.

At no time will security officers oversee inmates, Ottawa County Deputies and Jail staff will be responsible for inmate activity to and from the jail, and while in the courthouse.

Security Officers will have a radio and if law enforcement is needed, they can be contacted.

Security company will need to be insured

Purchases by Ottawa County, Oklahoma are not subject to State or Federal taxes.

This bid is submitted as legal offer and any bid, when accepted by the Ottawa County, constitutes a firm contract.

Oklahoma laws require each vendor submitting a bid to a County Entity for goods or services to furnish a notarized sworn Statement of Non-Collusion (form supplied below).
