- 22. Commissioners' activity reports. District 1: Commissioner Furnas reported his crew is putting things back together again after the rain and snow storms. They will be helping with the city of Miami on the citywide cleanup project. District 2: Commissioner Chasteen reported 245 families were stranded due to the recent flooding in his district. This damage would take 6 million dollars to repair to engineering standards. 1 million to band aid it together. Chasteen wants the State to know that Ottawa County needs matters, and we need assistance to repair problems adequately, instead of the band aid method. We are also continuing to work on roads in all seven zones. Council House Rd. remains closed. Chasteen is also looking for property out of the flood zone for the purpose of establishing a new building since the current building is in the flood zone, and does flood frequently. District 3: Commissioner Earls reported no injuries in an accident one of his crew members was involved in. He reminded the Commissioners' they are responsible for their own high deductible in such a case. He and crew are also cleaning and repairing after the latest storm. They will begin work on sulphur bend loop, part of the 5 year plan.
